1. Enquiries about Examination Results (EAR)/ Re-corrections

Applications for **Enquiries about Examination Results** should be made only in respect of candidates whose performance differed markedly from their teachers' expectations.

- You can only submit requests for Enquiries about results for components (Papers).
- You can only submit all the components in the syllabus for the same post-results service. For example, you cannot request a Service 1S for one component and then a Service 2S for another component if they are components of the same syllabus.
- All the components you want to review within the same syllabus must be submitted at the same time. The exam board cannot accept enquiries for additional component/s for the same candidate and syllabus at a later date

Deadline for Enquiries about Examination Results (EAR): 10 September 2022.

We'll not be able to accept any requests for EAR after this date.

Enquiries about results may take **approximately one month (30 days)** to complete. Outcome will be sent to the registered email address.

The following information explains what may happen when you apply for Enquiries about Results and your papers are remarked.

1. Your original mark is lowered; as a result your final grade may be lower than the original grade you received.
2. Your original mark is confirmed as correct and there is no change to your grade.
3. Your original mark is raised: as a result your final grade may be higher than the original grade you received. If the change of marks results in a grade change, you will receive a refund.

What happens when an enquiry about results is submitted to the exam board?

When an enquiry about results is received, the exam board will appoint another examiner so that there is an independent review of the marking of the work. The reviewing examiner has been through the same training as all the other examiners marking the paper and will have marked many candidate answers. Exam board will correct any administrative marking errors that are found. Marking errors include incorrect addition of marks, errors in transfer of marks from exam paper to computer screen, and partly unmarked scripts.

Certificates for private candidates will be couriered to you in September 2022 –, while school candidates' certificates will be sent to the respective schools.
