Refunds

Refund of fees for EAR will be given to the candidates on following circumstances only;

For IAL

- Candidates who have cashed-in (ie, have been awarded an overall subject grade in the subject concerned), refund of fees will be applied where the EAR **leads to an improvement** in the **overall subject grade**.
- Candidates who have not cashed-in (ie, have not yet been awarded an overall subject grade in the subject concerned), refund of fees will be applied where the EAR **leads to an improvement** in the **unit grade**.
- Candidates who have cashed-in and applied for multiple EARs supporting the same subject grade, refund of fees will be applied only for the unit EAR(s) **lead to an improvement** in the **overall subject grade**.

For International GCSE

- Candidates who have applied for multiple EARs supporting the same subject grade, refund of fees will be applied only for the unit EAR(s) **lead to an improvement** in the **overall subject grade**.

Data changes

The local deadline for data changes is 02 April 2021.

If there are any mistakes with regard to the spelling of your name, date of birth etc. please forward them to us as soon as possible. **Any subsequent changes will be charged LKR 16,500/- as this will require a new certificate.**

Grade upgrading

Candidates who have cashed-in and have received an overall grade for a subject but are not satisfied with their grade can still re-sit units subject to IAL and GCE qualification guidelines. However, any improved unit marks will not be added to the current grade. Therefore you are required to reapply for cash-ins in order to obtain the updated overall grade.

Late cash-ins for January 2021 exam series

Absolute closing date for AS or A-level Late Cash-in requests is **02 April 2021**

Candidates who have completed an adequate number of units or have no intention of re-sitting any units in future exam sessions **MUST CASH IN** on or before **02 April 2021** in order to obtain a certificate. A fee of **LKR 2,000.00** will be charged for each **Late Cash-In** syllabus specification plus an additional **LKR 2,100.00** per candidate fee.

Late cash-ins for January 2021 are only allowed up to this date. If you do not cash-in, you will not receive a subject grade/certificate.
