



Pearson Edexcel Examinations: May/June 2026 Results

Important Deadlines and Processing Timelines:

Form	Deadline	Processing timelines
EAR (Enquiry About Results)	11 September 2026	Approximately 35 days from payment confirmation.
ATS (Access to Scripts)	01 September 2026	Approximately 3 days from submission acknowledgement.
Late Cash-In / Data Changes	04 September 2026	Candidates will be informed of the status on or before 31 September 2026.

1. Enquiry about Examination Results (EAR) / Re-correction

Service 1 – Clerical check	A check of all clerical procedures which lead to issuing a result. This service will include the following checks: - all parts of the exam paper have been marked. - marks have been recorded/added up correctly. - special consideration has been applied (where appropriate) - the grade boundaries have been applied accurately. Service 1 + Reviewed Script	The same as a 'clerical re-check' but you also get a copy of the reviewed script.	LKR 12,760	LKR 12,760
Service Type	Service Description	IAL Fees per Unit	IGCSE/IPLS Fees per Paper
Service 2 - Review of marking (Externally assessed components)	A post-result review of the original marking to ensure that the agreed mark scheme has been applied correctly. It is not a re-marking of the candidate's script. This service will include the following checks: - the clerical re-checks detailed in EAR Service 1 - a review of the original marking to ensure that the agreed mark scheme has been applied correctly. (*This service is not available for internally assessed/externally moderated coursework components.)	LKR 25,080	LKR 22,000
Service 2 + Reviewed Script	The same as a 'review of marking' but you also get a copy of the reviewed script.	LKR 31,680	LKR 28,600



- Please note that only review of moderation (Service 3) service is available for 9FA0. If you wish to apply for EAR service for this subject, please write to info.lk@britishcouncil.org for further information on the process and fees.

Refunds for EAR are given only under the following circumstances:

IAL:

- Cashed-in Subject (i.e., awarded an overall subject grade) – If the EAR leads to an improvement in the overall subject grade.
- Non cash-in Subject – If the EAR leads to an improvement in the unit grade.
- Cashed-in Subject with multiple units requested for EAR- Only the EAR unit contributing towards an improvement in the overall subject grade will be refunded.

Note: Candidates' marks and subject grades may be confirmed, lowered or increased. Where there has been a reduction in marks or a downgrade, the request cannot be revoked, and the original mark or grade cannot be reinstated. If the candidate is eligible for a refund, it will be processed within six weeks of receiving the outcome for the Enquiry.

2. Access to Scripts (ATS)

Service Type	Service Description	Fees per Unit / Paper
Access to Scripts (Copy of scripts to support EAR)	Access to Script service allow you to request copies of your marked exam papers. Scripts do not have examiner annotation on them, but you can see the marks. Copy of scripts are available for candidates to decide whether to go ahead with an EAR Service request. <i>School Candidates: Need to Apply through their respective school.</i>	No Fee

3. Late Cash-In for May/June 2026 series

Candidates, who have completed the required number of units, may apply for this service.

Fees

- Per Cash In – **LKR 7,800**

Note: Late Cash-ins for May/June 2026 series are only allowed up to the above deadline. Any cash in requests made after the above date will need to be submitted as a Special Late cash-In request.

Requirements:

- Late Cash-In application form.
- Copies of Statements of Results (*Copies of Current and all relevant previous results sheets*)
- Copy of your ID (*Name should appear in English*)

4. Data Changes

If there are any mistakes in the spelling of your name, date of birth and gender, apply for “Data Changes” before the given deadline using the form linked below.

Note: Any requests submitted after the above deadline will be subject to board approval and fee of LKR 33,880.

5. Online Results

Results release time:

- IAL - **13 August 2026 (After 01:30 pm)**
- IGCSE/ IPLS - **20 August 2026 (After 01:30 pm)**

You will receive your Electronic Statement of Results within 24 hours of the results release timeline mentioned above.

- Private Candidates - Sent via email to the registered email address.
- School Candidates - Sent to the respective schools.



6. Hard Copies of Statement of Results (SOR) and Certificates

You will receive your SOR **within 14 days of ESOR Release** and the Certificate by **early December 2026**.

- **Private Candidates** – Will receive via courier to the exam registered address
- **School Candidates** - Sent to the respective schools.

Note: Candidates, who wish to receive the Certificate to an overseas address, will need to make the request using below link by **10 August 2026**.
