# 1. Enquiry about Examination Results (EAR) / Re-correction

IAL /IGCSE Deadline – 18 September 2025 (Late requests will not be accommodated)

Service 2 + Reviewed Script	The same as a 'review of marking' but you also get a copy of the reviewed script.	LKR 28,600	LKR 31,680

#### **Special Note:**

For **9FAO** - Only review of moderation (**Service 3**) is available. Any EAR requests for this subject need to be emailed to info.lk@britishcouncil.org for further information.

### Refunds for EAR are given only under the following circumstances:

#### IAL:

For Cashed-In subject(s) (i.e. awarded an overall subject grade) – If the EAR leads to an improvement in the overall subject grade.

If Not Cashed-In – Only if the EAR leads to an improvement in the unit grade.

Cashed-In subject(s) with multiple units requested for EAR - Only the unit(s) contributing towards an improvement in the overall subject grade will be refunded.

#### **IGCSE:**

Refund (per relevant subject) will be applicable only if the EAR service leads to an improvement in the overall subject grade.

**Note:** Candidates' marks and subject grades may be confirmed, lowered or increased. Where there has been a reduction in marks or a downgrade, the request cannot be revoked, and the original mark or grade cannot be reinstated.

# 2. Access to Scripts (ATS)

Access to Scripts (Copy of scripts to support EAR)	Access to Script service allow you to request copies of your marked exam papers. Scripts do not have examiner annotation on them, but you can see the marks.  Copy of scripts are available for candidates to decide whether to go ahead with an EAR Service request.	LKR 2,500
	School Candidates: Need to Apply through their respective school.

Deadline - 25 August 2025 (Late requests will not be accommodated)

#### **Fees**

Per Cash In/Subject Award – LKR 7,700

#### Important:

- This service is available only for British Council or British Council Partner School Candidates.
- Candidates are required to ensure all the corresponding units have been completed for the respective Subject Awards under the same Unique Candidate Identifier Number (UCI Number).

#### **Requirements:**

- ✓ Completed Late Cash-in Application Form
- ✓ Confirmation / Screenshot of Bank Transfer
- ✓ Statements of Results (Current and all relevant previous results sheets)
- ✓ Copy of your ID (NIC/Passport) (Name should appear in English)

## 6. Hard Copies of Result Sheets (SOR) and Certificates

You will receive your SOR within 14 days from ESOR Release and Certificates by 15 Nov 2025.

- Private Candidates Will receive via courier to the exam registered address.
- School Candidates Sent to the respective schools.
